

## GIBA Tournament Results

The first three tournaments of our 2008-09 season are in the books. The first two tournaments were both contested on patterns other than the typical 'house' shot. The first tournament featured a pattern provided to Cadillac Lanes by Kegel, and the second was on a pattern the staff at Merle Hay Lanes provided for us. The scoring level was similar for both tournaments, and it was important to make accurate shots and pick up spares in order to score.

Congratulations to Mike Peters who won our first tournament, the Rick Eighme Memorial 12 gamer at Cadillac Lanes. Mike topped a field of 43 bowlers with an average of 220.7 for the 12 games. We paid a total of 12 spots, and it took a score of 2420 to cash. Shannon Buchan was 2<sup>nd</sup>, followed by Duane Kilts, Jacob Bedard, Bob Hochrein, Matt Smith, Bryan Tippett, and Don Breeden. A special thank you goes out to Cadillac Lanes for working with Kegel on the pattern, and for hosting this tournament. We had some great sponsorship for this tournament with added money from Budweiser and also from Fran's Pro Shop for donating 3 Hammer bowling balls for the 4 game block totals.

Our second tournament at Merle Hay was a combination GIBA/Mid-Iowa BA tournament. We had a total of 53 entries for this tournament. Congratulations to Matt Smith who won the step ladder final after finishing as the top qualifier after 8 games of qualifying. Matt averaged 223.1 for the 8 games, and it took a score of -1 to cash. Matt Smith topped Matt Weggen in the final match with Mike Peters finishing 3<sup>rd</sup>, Blake Lobdell 4<sup>th</sup>, and Scott Carpenter 5<sup>th</sup>. We owe a huge thank you to Mark Olson and Merle Hay Lanes for working with us on the pattern, and also providing \$250.00 in added prize money. Brunswick provided a bowling ball for our raffle and they have been a great sponsor for the GIBA over the past several years.

October 25<sup>th</sup> was our annual Big Gun tournament at Totem Bowl in Marshalltown. We had 41 entries for this tournament, and Don Breeden lapped the field winning the 12 game sweeper by over 100 pins. Less than 100 pins separated 2<sup>nd</sup> thru 13<sup>th</sup> places so it was closely contested other than Don. Other top finishers were Bob Hochrein 2<sup>nd</sup>, Shannon Buchan 3<sup>rd</sup>, Mike Peters 4<sup>th</sup>, and Brett Lobdell 5<sup>th</sup>. The scoring level was relatively high on the new Brunswick synthetic lanes Totem Bowl just recently installed, but the pattern played pretty fairly for everyone. I have included final standings with this letter.

I really appreciate the feedback I have received following the tournaments relating to the patterns we have used. In many cases, even the bowlers who didn't score well have made positive comments about the fairness of the condition. Our goal is to provide our bowlers with patterns that require good shot-making and make spares count. I want your input whether positive or negative on these patterns so please feel free to let me know your feelings.

The Iowa Open is next on November 16<sup>th</sup> at May City Bowl in Cedar Rapids. Remember, this tournament has a 9:00 AM starting time due to the longer format. It features the U.S. Open pattern with 8 games of qualifying and a 10 man round robin finals. The winner receives a paid entry to the U.S. Open. I also attached a flier for this tournament.

I attached a flyer for a PBA experience tournament being held on Sunday November 30th at Westdale Lanes in Cedar Rapids. Harry Hale is running this tournament using the Viper pattern and I told him I would send out his flyer. In addition, I have included a flyer for the Triple Elimination tournament on December 6<sup>th</sup> at Highland Park in Moline, IL. We have decided to add a Sunday tournament on December 7<sup>th</sup> at Highland Park which will utilize a unique one ball format. I will have more details on that one in my next mailing. The annual 50/50 doubles will be December 28<sup>th</sup> and I have attached a flyer for that tournament. There is also a flyer attached for a 3 man team event to be held at Cadillac Lanes on December 27<sup>th</sup>. We have obtained \$2000.00 in added prize money for the two tournaments with \$1000.00 of the total going to each. The Saturday tournament will require at least one bowler over 50 and one under 50 while the third team member can be any age. There are several reasonably priced hotels in the area around Cadillac Lanes for those wishing to bowl both tournaments. The Saturday tournament is limited to the first 32 teams entered and Sunday always fills so get your entries in early.

# SSBA 50/50 SCRATCH DOUBLES BOWLING TOURNAMENT

DATE: DECEMBER 28, 2008

AT: CADILLAC LANES, WATERLOO, IA

**OBJECTIVE:** To provide and conduct an annual scratch doubles bowling tournament for USBC certified bowlers.

**ELIGIBILITY:** Membership and tournament participation is open to all male and female bowlers in good standing with the USBC. One member of each doubles team must be age 50 or older and the other team member must be younger than age 50 as of the scheduled tournament date. Only one division will be conducted with men and women competing together. Eligible entrants without USBC membership cards must apply for associate membership by paying \$16.00. (Rule 300c)

**Senior bowlers (over age 50) must be members of the Seniors Scratch Bowling Association (SSBA) with paid up annual membership dues of \$10.00. Payment of SSBA membership \$10.00 dues should be included with tournament entry if not already paid.** Professional bowlers meeting all other eligibility requirements are allowed to enter.

**USBC CERTIFIED:** This tournaments will be USBC certified.

**TOURNAMENT ENTRY PROVISIONS:** This tournament is limited to 75 sets of doubles entries. Only the first 75 paid entries are guaranteed a spot in the tournament. Additional entries will be placed on a waiting list in a first come-first served priority and will be provided a spot as available.

**TOURNAMENT ENTRY FEE:** \$55.00 per bowler for a total of \$110.00 per doubles team.

Optional \$6.00 jackpots for high games rolled during qualifying games only are available for all bowlers.

Optional multiple brackets are available for bowlers.

**TOURNAMENT ENTRY FEE BREAKDOWN:** Prize Fund = \$75.00    Bowling = \$26.00    Expense = \$9.00

**TOURNAMENT PAY OUT RATIO:** Major Prize Fund = 1: 3    All major prize fund fees collected will be returned 100% to the participants (Rule 308). Any added prize money obtained from sponsorship, donations, or fund raising efforts will be disbursed evenly throughout all places cashing in the major prize fund.

Optional Jackpots = 1: 10    All jackpot fees collected will be returned 100%.

All major prize list money will be paid out on tournament day. All jackpot prize money will be mailed to winners along with tournament final results.

**TOURNAMENT STARTING LANE ASSIGNMENT:** Doubles teams will be assigned starting lanes by tournament officials. Entries close at tournament starting time. Please check-in with tournament officials as soon as possible after 8:30 A.M. on tournament date, but not later than 30 minutes before tournament scheduled starting time as a courtesy to help your tournament officials complete pre-tournament paperwork to allow qualifying to start promptly on time.

**TOURNAMENT QUALIFYING FORMAT:** All tournament scores are scratch (without handicap). Each doubles team will bowl six (6) qualifying games, moving to a different pair of lanes after completion of each game. All bowlers will alternate between the even numbered and odd numbered lane as their starting lane for each successive qualifying game. Bowlers will be responsible for keeping their own scores (as required when automatic scorekeepers are not available), checking the accuracy of their scores, transferring their scores to the tournament recap sheet, and submitting the recap sheet to the tournament officials. The tournament recap sheets are the official score sheet and must be completed and turned in to the tournament officials.

**TOURNAMENT FINALS FORMAT:** Based on total pins scratch from the six (6) qualifying doubles team games, the top five (5) doubles teams will advance to a stepladder format to determine the tournament champion. In case of any ties for the top four (4) qualifying spots, or for 5th and 6th high qualifying, there will be a one game roll-off to determine the qualifying placement. If a tie still exists after the additional game, there will be a 9th and 10th frame roll-off to be repeated until the tie is broken. In case of a tie for 4th and 5th place qualifying spots only, there will be a coin toss to determine qualifying placement.

**SQUAD TIMES FOR QUALIFYING:** Qualifying will begin at 10: 00 A.M. and will be completed in one (1) squad. This tournament is a one (1) day tournament started and completed on the respective scheduled tournament date.

**TOURNAMENT MANAGEMENT:** All situations not covered under above rules will be decided by USBC rules.

Tournament management has supervisory control of all technical parts of the tournament operations and authority to decide and settle any disputes or complaints. (Rule 303) Tournament management has the authority to reject acceptance of any entry.

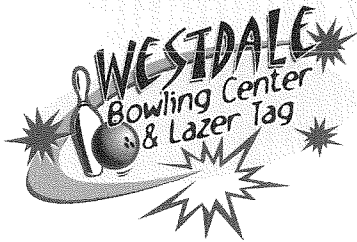
