50/50 SCRATCH TEAM BOWLING TOURNAMENT FOR DECEMBER 10, 2011

OBJECTIVE: To provide and conduct an annual scratch four person team bowling tournament for USBC certified bowlers.

ELIGIBILITY: Membership and tournament participation is open to all male and female bowlers in good standing with the USBC. For each four-person team, two members must be age 50 or older and two members must be younger than age 50 as of the scheduled tournament date. Only one division will be conducted with men and women competing together. Eligible entrants without USBC membership cards must apply for associate membership and pay respective fees. (Rule 300c) **All senior bowlers (over age 50) must be members of the Seniors Scratch Bowling Association (SSBA) with paid up annual membership dues of \$10.00.** Professional bowlers meeting all other eligibility requirements are allowed to enter.

USBC CERTIFIED: This tournaments is USBC certified.

TOURNAMENT DATE AND TIME: December 10, 2011 at 1:00 P.M.

Reservations are requested but walk-in entries will be accepted.

TOURNAMENT ENTRY FEE: \$40.00 per bowler for a total of \$160.00 per team.

Optional \$6.00 high game singles jackpots for first three games of qualifying available for all bowlers.

TOURNAMENT ENTRY FEE BREAKDOWN: Prize Fund = \$110.00 Bowling = \$40.00 Expense = \$10.00

TOURNAMENT PAY OUT RATIO: Major Prize Fund = 1: 3 All major prize fund fees collected will be returned 100% to the participants (Rule 308). **Any added prize money obtained from sponsorship, donations, or fund raising efforts will be disbursed evenly throughout all places cashing in the major prize fund.**

Optional Jackpots = 1: 10 All jackpot fees collected will be returned 100%.

All major prize list and jackpot money will be paid out by December 11, 2011 if possible.

TOURNAMENT STARTING LANE ASSIGNMENT: Teams will draw for starting lanes. Entries close at tournament starting time. Please check-in with tournament officials 30 minutes before scheduled starting time as a courtesy to help your tournament officials complete pre-tournament paperwork to allow starting promptly on time.

TOURNAMENT FORMAT: All tournament scores are scratch (without handicap). Each team will bowl three (3) games, moving to a different pair of lanes after completion of each game. All bowlers will alternate between the even numbered and odd numbered lane as their starting lane for each game. Bowlers will be responsible for keeping their own scores (as required when automatic scorekeepers are not available), checking the accuracy of their scores, transferring their scores to the tournament recap sheet, and submitting the recap sheet to the tournament officials. **The tournament recap sheets are the official score sheet and must be completed and turned in to tournament officials.** At the completion of three games, the field will be cut to the top one-half of the teams plus one additional team if required to provide an even number of teams. Each advancing team will draw for lanes to bowl one additional game. Based on total pins for their four games the field will again be cut to the top one-half of the teams plus one additional team if required to provide an even number of teams. Each advancing team will draw for lanes to bowl one additional game. Based on total pins for their five games the field will be cut to the top four (4) teams that will bowl one game matches in a stepladder format to determine the tournament champion.

TOURNAMENT FINAL STANDINGS: First place through fourth place will be determined by the stepladder results. The balance of the teams cashing in the prize list will be in order of finish based on their total pin fall scratch.

STARTING TIME: Tournament will begin at 1:00 P.M on December 10, 2011. This tournament is a one (1) day tournament started and completed on the respective scheduled tournament date.

TOURNAMENT MANAGEMENT: All situations not covered under above rules will be decided by USBC rules. Tournament management has supervisory control of all technical parts of the tournament operations and authority to decide and settle any disputes or complaints. (Rule 303) Tournament management has the authority to reject acceptance of any entry.
