Tournament Details:

Greater Iowa Bowling Association - All bowlers must pay the \$10.00 GIBA membership fee.

Pattern - Tournament will feature a USBC national tournament pattern to be determined.

Field - The field will be limited to the first 128 paid entries. Past GIBA members will be guaranteed spots if entry fee is paid by August 1st after which the field will be opened for new member entries. New member paid entries will be accepted at any time with the spots being assigned in the order those entries are received until the field is full. Any paid entry not receiving a spot will be refunded in full.

Eligibility - All USBC members are eligible to bowl including exempt PBA professionals.

Qualifying - Two qualifying squads will be held on Saturday at 9:00 AM and 1:30 PM with the tournament administrator assigning squads. Qualifying will consist of an 8 game block moving after each game across the house.

Round 2 – The field will be cut to at least the top 56 entries (based on 128 entries) for a second round of 6 games at 9:00 AM Sunday morning. All pins will carry over from Saturday.

Finals - The top 4 total pins following Sunday's squad will be seeded into the stepladder finals with places 5-10 bowling elimination matches to determine the final spot in the stepladder. The elimination bracket will be set up 7vs10 & 8vs9 for one game matches with 5 & 6 to meet the winners of those two matches. The winners move to the next round until one bowler is left to join the top 4 qualifiers. A TV style stepladder will be used to determine the winner.

Brackets - offered on all squads with at least 50% of proceeds going back into the prize fund.
