Rules (USBC Sanctioned)

- 8 Games will be bowled on eight different pairs of Lanes
- All Scores will be Scratch
- Each shift will be Limited to 48 bowlers. If 2nd Shift is not full, bowlers from the first shift may re-enter on a luck-of-the-draw basis. Their 1st shift scores will then be thrown out!
- Lanes will be conditioned before the 2nd shift and Finals.
- The top 12 finishers will advance to the finals. Finals format will be 3-man single elimination. (Winner of the 12th, 11th, & 10th place match will bowl 9th & 8th place, that winner will bowl the 7th & 6th place, etc. until two bowlers are left to decide the champion.)
- In the event there is a 12th place tie, a one game roll off will be held.
- Other ties will be broken with a coin toss.
- Only USBC sanctioned bowlers are eligible to compete. Unsanctioned bowlers may qualify to compete by paying affiliate membership fee of \$20.00. Option: unsanctioned bowlers may pay a \$5.00 participation fee and bowl in this tournament. They will not be eligible for USBC awards.
- Tournament will be held Saturday, January 11th 2014. **ENTRIES CLOSE at 2:30 pm on January 11th 2014.**
- Entry Fee **MUST** be received *prior* to bowling.
- All scores will be scratch. In the event of a tie at the end of a match, bowlers will bowl the 9th & 10th frame over until the tie is broken.
- All decisions of the tournament committee are final, although appeals may be made in accordance with USBC rule 329.
- Rule 319d (reporting of prize winnings) does not apply and rule 319e will be waived.

ADVANCE RESERVATIONS WILL BE GIVEN PRIORITY

Walk-ins will be taken to fill up a shift ONLY if necessary!
