### **Tournament Entry fee's and Expenses – Tier 1 Entry**

The tournament entry fee is \$57.00. The only tournament expenses are the bowling fees. The bowling fees are \$14.00 per player. **This tournament will have a minimum of \$500.00 in added prize money!!**

### **Prize Ratio:**

The prize ratio is 1 to 4. All prize fees are to be returned 100%.

### **Tier 2 Entry Fee – Optional**

The entry fee for tier 2 is \$30.00. There are no expenses so 100% of the entry fees will be paid out as prize money. The prize ratio is 1 to 4 and the order of finish is determined from the 8 game totals of all bowlers entering this optional tier. Please contact the tournament administrator with questions concerning this optional entry.

### **High Game Pots and Brackets:**

**Optional** high game pots (for \$8.00) will be collected. **Optional** singles brackets (**limit 80**) will be available for this tournament.

### **Bet You Win Pot**

**Optional bet you win pots will be collected for both tier 1 and tier 2. The entry for this optional pot is \$10.00 for each tier. A bowler may enter either one or both optional pots. The winner of each tier will collect the total pot for that tier if they are entered in the pot. If the winner of a tier is not entered in the pot, the total for that tier will carry over to the next tournament.**

### **Qualifying:**

Bowlers will bowl 8 games of qualifying across 16 lanes.

### **Finals:**

The field will be cut to the top five bowlers for the stepladder finals. In case of a tie for fifth place a one game roll-off will be held to determine the bowler that will bowl in the finals. In case of a tie for 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> places, a one game roll-off will be held to determine position in the stepladder finals. Each match in the stepladder will be bowled on a different pair of lanes and the lanes will not be redressed prior to the finals. The higher seed in each match will have lane choice at the start of the match. In case of a tie for the 4<sup>th</sup> and 5<sup>th</sup> positions from qualifying, a coin flip will be used to determine the starting lanes. If a match ends in a tie, a ninth and tenth frame roll-off will be used to determine the winner, repeating the roll-off until a winner is determined.

This tournament is certified by the USBC. All bowlers must be USBC members.
